2 A RESOLUTION OF THE LONGMONT CITY COUNCIL URGING LONGMONT  
3 CITIZENS TO VOTE “YES” ON THE BALLOT QUESTION APPROVING A \$739.8  
4 MILLION BOND FOR THE ST. VRAIN VALLEY SCHOOL DISTRICT RE-1J, ON THE  
5 NOVEMBER 5, 2024 STATEWIDE ELECTION BALLOT

7 WHEREAS many of the school-age children residing within the City of Longmont attend  
8 St. Vrain Valley School District RE-1J; and

9 WHEREAS a healthy economy in the City of Longmont is directly affected by the  
10 quality of education of its school-age children; and

11 WHEREAS without increasing taxes, the St. Vrain Valley Board of Education has placed  
12 a \$739.8 million bond on the ballot in 2024 that will ensure the district’s continued commitment  
13 to academic excellence, accountability, safety, and providing the education that today’s students  
14 will need for tomorrow’s jobs and careers; and

15 WHEREAS, the Longmont City Council finds that approval of this bond issuance is  
16 necessary for the St. Vrain Valley School District RE-1J to provide excellent educational  
17 opportunities to children in Longmont who attend these schools; and

18 WHEREAS, the Longmont City Council finds that approval of this bond issuance is  
19 therefore in the best interests of the City and its citizens and should be supported.

20 NOW, THEREFORE, THE COUNCIL OF THE CITY OF LONGMONT, COLORADO,  
21 RESOLVES:

1 Section 1

2 For the reasons stated above, the Longmont City Council supports the ballot issue  
3 approving a \$739.8 million bond for the St. Vrain Valley School District.

4 Section 2

5 The City Council urges Longmont citizens fully to inform themselves about the ballot  
6 issue approving a \$739.8 million bond for the St. Vrain Valley School District.

7 Section 3

8 The City Council urges Longmont citizens to vote “Yes” on the ballot issue approving a  
9 \$739.8 million bond for the St. Vrain Valley School District.
