**SUBJECT/AGENDA TITLE:**

A Resolution Of The Longmont City Council Authorizing The Exercise Of The City's Power Of Eminent Domain To Acquire Certain Real Property Interests Necessary For Public Purposes In Connection With The St. Vrain Greenway Trail Project

**EXECUTIVE SUMMARY:**

This item seeks City Council approval of a resolution superseding the prior resolution for authorization of eminent domain for the St. Vrain Greenway Trail Project. Due to a technical error, two pages of the legal description were inadvertently omitted from the resolution City Council approved at the June 25, 2024, meeting. Out of an abundance of caution, staff is requesting City Council to approve a superseding resolution with the full legal description attached.

**COUNCIL OPTIONS:**

Approve or reject the superseding resolution authorizing eminent domain for the St. Vrain Greenway Trail Project.

**RECOMMENDED OPTIONS:**

Approve the superseding resolution as presented.

**FISCAL IMPACT & FUND SOURCE FOR RECOMMENDED ACTION:**

No additional fiscal impact beyond what was presented in the June 25, 2024, City Council Communication (Attachment 2).

**BACKGROUND AND ISSUE ANALYSIS:**

On June 25, 2024, City Council passed and adopted Resolution R-2024-42, *A Resolution of the Longmont City Council Authorizing the Exercise of the City's Power of Eminent Domain to Acquire Certain Real Property Interests Necessary for Public Purposes in Connection with the St. Vrain Greenway Trail Project*. Although all the information in the June 25<sup>th</sup> City Council Communication (Attachment 2) and resolution was accurate, two pages of the legal description for the 0.94-acre permanent easement were inadvertently omitted from the
