**Briefly explain what you believe are the two most important issues facing City Council and how do you believe those issues should be addressed? \***

The two most important issues facing Longmont are maintaining a fiscally sound budget and continuing to deal with the housing crisis.

1. Without a fiscally sound budget to run the city nothing else is possible for Longmont. It is the foundation of the government. Having been through eight city budget cycles, I am very familiar with the very hard choices sometimes necessary in order to sustain the city's future.

2. The housing crisis is very complex and longstanding. The current Council has done a very good job as LHA Commissioners at providing more housing. There are still more creative options to consider for low-end housing. Fifty percent of Boulder County residents are financially stressed by their housing. If we do not have any programs (except vouchers) to help those making under 50% AMI, the number of stressed and homeless will only increase.

## Letter of Interest for Ward 2 Appointment

Mayor and Councilors,

Polly Christensen here. I am sure most of you are surprised to see me expressing an interest in the appointment as my ward representative. This is an odd offer for an odd position that has been created by Councilor Martin. I would gladly serve as Ward 2 representative for 10 months, AND 10 MONTHS ONLY. I doubt that you will take me up on this, but here is why I think you should do this:

I foolishly still believe in democracy. Whoever is appointed by Council, should they run in the fall (and you know they will) is likely to win because this fall's election is an off-presidential year and will have low voter turnout; those with greater name recognition and incumbency have a tremendous advantage with the voters.
