

ORDINANCE O-2024-

A BILL FOR AN ORDINANCE CONDITIONALLY APPROVING THE VACATION OF TWO LPC EASEMENTS, TWO UTILITY EASEMENTS, TWO SANITARY SEWER AND WATER EASEMENTS, AND TWO DRAINAGE EASEMENTS LOCATED WITHIN THE BOUNDARY OF LOTS 5 & 6 OF IRWIN THOMAS FIRST FILING FINAL PLAT, GENERALLY LOCATED AT 200 BOUNTIFUL AVENUE, WEST OF HARVEST MOON DRIVE AND SOUTH OF EAST KEN PRATT BOULEVARD AND COSTCO

WHEREAS the City of Longmont has received a petition and application to vacate eight easements described in the attached Exhibit A.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF LONGMONT, COLORADO, HEREBY ORDAINS:

Section 1

Vacation of the easements described in Exhibit A satisfies the review criteria of sections 15.02.055 and 15.02.060.H.2 of the Longmont Municipal Code.

Section 2

The City Council approves the vacation of the easements described in Exhibit A, subject to satisfaction of the following requirements within one year of the date of passage of this ordinance:

1. The approval and recording of Irwin Thomas First Filing Replat C Final Plat.
2. Satisfaction of the submittal requirements of the Longmont Land Development Code.

After the City of Longmont Planning and Development Services Director certifies satisfaction of the foregoing requirements, the City Manager or designee shall record this ordinance with the County Clerk and Recorder.

Section 3

The effective date of this vacation shall be the date this ordinance is recorded with the County Clerk and Recorder.

Section 4

To the extent only that they conflict with this ordinance, the Council repeals any conflicting ordinances or parts of ordinances.
