

## ORDINANCE O-2024-

A BILL FOR AN ORDINANCE ADOPTING THE 2024 FLOOD INSURANCE STUDIES  
AND THE FLOOD INSURANCE RATE MAPS AND MODELS FOR WELD AND  
BOULDER COUNTIES

THE COUNCIL OF THE CITY OF LONGMONT, COLORADO, ORDAINS:

## Section 1

The Council designates and approves the Flood Insurance Study (FIS) and the Flood Insurance Rate Maps (FIRMs), prepared by the Federal Emergency Management Agency, for Weld and Boulder Counties, Colorado and Incorporated Areas, dated September 26, and October 24, 2024, respectively, supplementing the special flood hazard areas identified as described in section 20.12.020 of the Longmont Municipal Code. At the time of designation and approval, one certified true copy of the 2024 FISs and FIRMs for both counties may be inspected in the office of the floodplain administrator by any interested person between 8:00 a.m. and 5:00 p.m., Monday through Friday, holidays excepted. The 2024 FISs and FIRMs, as finally designated and approved, will also be available to members of the public on the Federal Emergency Management Agency's website, as well as the City of Longmont's website.

## Section 2

To the extent only that they conflict with this ordinance, the Council repeals any conflicting ordinances or parts of ordinances. The provisions of this ordinance are severable, and invalidity of any part shall not affect the validity or effectiveness of the rest of this ordinance.
