Why are you interested in serving as a City Council Member? *

I am interested in serving on City Council because I care about and want to support the people of Longmont. I very much support the City Council's Vision for People and Place, as well. I know how important it is to have Council Members that care about the community, take the time to study policy, and listen to the concerns of people around them – and I know I can do that as a Council Member. I also have experience working with the city, as a contractor for the federal government, and as a board member that uniquely helps prepare me for a role on the City Council.

Briefly explain what you believe are the two most important issues facing City Council and how do you believe those issues should be addressed? *

The biggest issues facing City Council are the minimum wage and affordable housing. Right now, the goal of Boulder County is to increase the minimum wage to \$25 an hour, which if done today, may close down many small local businesses. However, as housing prices rise in Longmont, the current minimum wage does not provide enough income to allow employees to afford to live in town (hopefully near where people work). This is why affordable housing is so crucial, along with helping the notable houseless community across Longmont.

The simplest change to address both these issues would be to increase the Minimum Affordable Housing Requirements to include more houses affordable to people at 80% of the Area Median Income, as well as at 50% and lower. I would also want to work more with local businesses on the best ways to increase the minimum wage moving forward.

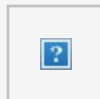
