#### 1. MEETING CALLED TO ORDER

The December 17, 2024, Regular Session of the Longmont City Council was called to order at 7:00 p.m. by Mayor Joan Peck in the City Council Chambers.

**7. SPECIAL REPORTS AND PRESENTATIONS**

**A. 2024 Longmont Community Satisfaction Survey Results**

Becky Doyle, Executive Director of Strategic Integration, along with Ana Castro, Data and Innovation Analyst, and Lynn Yarmey, Data and Analytics

Manager, shared the results of the first Citizen Satisfaction Survey done by city staff without contracting an outside vendor.

Castro reviewed the history of the survey, the methodology for conducting the survey, and noted that fewer than 1% completed the survey in Spanish. The Satisfaction Survey started in 1996, has been run every two years but was paused in 2020 due to COVID. In 2022 the survey was restarted with a new vendor and questions. For 2024, staff ran the survey in-house utilizing Qualtrics, a new tool acquired by the City. This new approach has many benefits including:

- Can re-use software tool for other purposes
- Have ongoing access to survey data
- Can optimize survey over time
- Part of Digital Transformation to improve communication with community over time.

Castro continued her presentation and shared that 4,000 randomly-selected households with addresses balanced across the three Wards and types of home were mailed printed surveys. Most of the survey questions were replicated from 2018 and are meant to prove the new survey tool and processes with direct comparability. The survey had a 16% response rate which meets statistical significance. Lastly, before walking through the specific survey results for each question asked, Castro said the results are reported within +/- 5% margin of error.

After reviewing the Citizen Satisfaction Survey Results, Castro and Doyle shared that the generalized conclusions from the survey included mostly positive feedback and results from the community and areas of concern noted as traffic, homelessness, and financial struggles. They further explained that in the future they hope to refine the questions and strategies, and to implement tools that will encourage more people to complete the survey and to complete it online rather than on paper.

Castro and Doyle engaged with the Council along with City Manager Dominguez about the ability to delve deeper into areas of the data if desired, about ways to engage larger segments of the community, and the idea of possibly identifying the top three concerns for each ward.

Greg Morrissey, 1648 Harvard Street, questioned the council about the process for the Ward 2 vacancy and said the residents need to vote on the new appointee.

Jordan Person, 640 Buchanan Lane, expressed her support for 9A regarding marijuana hospitality and encouraged the council to pass this ordinance on first reading which would move her one step closer to her dream of opening a spa using cannabis for massage.

Gary Hodges, 2148 Stuart Street, talked about the council appointment process and expressed that residents want someone who is an agent of the neighborhood. He noted that there are several strong candidates and reminded the Council of their ability to put equity in play in a meaningful way when they make this appointment.

Steve Altschuler, 1555 Taylor Mountain Drive, said the presentation on citizen satisfaction was excellent and suggested having ways to complete the survey at large community events like the Sunrise Stampede, Farmer's Market and Jazz Festival.

**10. ORDINANCES ON SECOND READING AND PUBLIC HEARINGS ON ANY MATTER**

**A. O-2024-83, A Bill For An Ordinance Amending Chapter 14.32 On Rates And**

## Regulations Governing Electric Service

Mayor Peck read the title of the ordinance into the record. She then explained for the public's benefit that the City purchases its electric from Platte River Power Authority and those costs are equitably divided throughout the city including among those who have solar and a subset of the rates is for solar customers. Residents who have solar will theoretically pay less and to make things equitable for all residents, the City will buy solar from residents in order to equitably distribute the rates and the purchase appears as a credit on their utility bill.

Mayor Peck opened the public hearing on this item.

Mike Baum, 5026 William Place, spoke as a member of Sustainable Resilient Longmont and said the board supports the movement toward renewable energy and is concerned that these changes go against the stated goal of encouraging renewable energy.

Elaine Derr, 708 Eldora Place, said she installed solar because Longmont promotes sustainable energy and alleged that these changes penalize those with solar installs and the companies who install solar. She asked the Council not to pass this ordinance.

Megan Dawe, 2045 Longs Peak Avenue, urged the city to take another look at changes to solar rates and suggested these changes would hamper adoption of more solar installations.

Claire Shlosser, 1510 Harlequin Drive, commented on the lack of clarity in the notice she received and wondered if adding a battery wall or doing maintenance on her grandfathered system would trigger the new rates.

Lawrence Beshear, 2 Western Sky Circle, explained that many solar users have carefully calculated their investment and the time to recoup their investment dollars and said these changes would make it take much longer to recover the expense of his system. He asked the Council to reconsider these changes and to knock down the credit for these systems.

Esraa Jallad, 1511 Lark Bunting Place, urged the council to reject the changes and explained it was a step backward for the community.

John Bales, 1511 Lark Bunting Place, echoed the comments in opposition to

the proposed changes to the solar credits and shared his view that the changes were not equitable. He echoed the comments that these changes would make it take even longer to recover the cost of a solar system.

Mayor Peck closed the public hearing.

Council requested staff to address the questions and concerns raised by the public.

Hannah Mulroy, Energy Portfolio Development Manager, informed the Council and public that staff spent a couple of years working on the analysis and reviewing industry best practices to inform these rate changes. She clarified that the credit rate for solar is 8.56 cents and noted this change would create opportunity for larger solar systems which the city has not been able to accommodate. She further explained that there is currently a \$64,000 subsidy for solar which could be a much larger dollar amount if solar growth and expansion continues. Mulroy said that staff did not anticipate that these changes would hamper growth and she noted that each user has the entire month in which to consume the energy produced by the system. Lastly, she explained that under this ordinance, any upgrade, expansion or change of ownership would cause someone to move to the new rates but maintenance of an existing system or the addition of a battery would not cause a user to move away from their legacy rate, and she noted that different lengths of time for legacy rates were considered in the analysis of the legacy rates.

Mayor Peck commented that Platte River is installing a huge solar array in Severance and the Rawhide Energy Plant will be retired in 2028.

Mulroy commented that more solar on rooftops is not getting us to our 100% renewable goal.

## **12. GENERAL BUSINESS**

### **A. R-2024-96, A Resolution Of The Longmont City Council Conditionally Approving The In-N-Out Conditional Use Site Plan Application**

Don Burchett, Planning Manager, introduced the item and explained the history of the property noting that when it was annexed, the city had to allow for mining to occur. The parcel was approved as a PUD with regulations for mining and annexed. In 2020, the Costco development came to fruition and a portion of the area was excluded from the mining plan. The other mining areas remain along with those on city property to the north. At the time when Costco was approved, the reclamation plan was also approved though it is an estimate and actual reclamation will depend on what is mined.

Burchett further explained that O-2021-16 requires that development adjacent to open space be approved by City Council and said this is the first time a project has triggered this requirement. In-N-Out is proposing a 3,800 square foot drive thru restaurant which does meet the review criteria for a secondary use but because it is a secondary use and technically adjacent to open space on the north, across the right-of-way as prescribed in the ordinance, it is presented to Council for consideration. Burchett added that staff had made finding that the criteria had been met and the plans include parking and stacking to accommodate 38 vehicles as well as spaces for electric vehicle charging in accordance with city regulations. The Planning and Zoning Commission, under PZR 2024-9B, recommended approval with two conditions:

1. Prior to the recordation of Notice of Site Plan Approval for the In-N-Out Restaurant Conditional Secondary Use Site Plan, the Irwin Thomas First Filing, Replat A Minor Subdivision Plat must be recorded.
2. The Applicant agrees to construct an ADA-compliant ramp on the applicant's southern property line concurrently or sooner of an ADA-compliant ramp constructed on the east-west sidewalk on the southside of North Costco Entrance private drive, provided there is an identified pedestrian crossing on the North Costco Entrance private drive in an agreeable location to the applicant.

Council Members recalled that they had previously decided to include the right-of-way separation for things that were across smaller streets, for example, when considering O-2021-16.

Daniel Pocius, Development Manager for In-N-Out, gave a brief presentation about the company, its history and community involvement. He also reviewed the project noting it was designed to meet or exceed code and requirements. He concluded by noting that the company is excited about this opportunity in the City of Longmont.

Mayor Peck opened the public hearing on this item.

Jake Marsing, 1818 Red Cloud Road, expressed his elation that In-N-Out is coming to Longmont and said he was impressed by the dialogue and process to recall discussions that happened years ago and about why things were considered. He urged the Council to adopt the resolution.

Lance Whittaker, 1750 Collyer Street, said it is just another burger joint.

Gary Hodges, 2148 Stuart Street, questioned the logic of having and requiring electric vehicle charging spots at a location that is so clearly designed for people to get in and out quickly.

Greg Morrissey, 1648 Harvard Street, said the In-N-Out in Aurora caused traffic jams and said it is going to be crazy when it opens.

Mayor Peck closed the public hearing.

Council Member Yarbrough asked Daniel Pocius if they offer a veggie burger and he indicated they do not. Yarbrough urged them to create one just for Longmont.
