THE COUNCIL OF THE CITY OF LONGMONT, COLORADO, ORDAINS:

Section 1

In this ordinance, ellipses indicate material not reproduced as the Council intends to leave that material in effect as it now reads.

Section 2

The Council amends section 6.65.040 License required, paragraph B only, of the Longmont Municipal Code, by adding italicized material and deleting stricken material, to read as follows:

1. The classification or classifications of sexually oriented business, according to the classifications listed in section 6.65.030, for which the applicant seeks a sexually oriented business or sexually oriented business employee license;

2. The applicant's full true name and any other names used in the preceding five years;

3. The applicant's current business address and telephone number and each individual applicant's current home address and telephone number;

4. ~~A set of the applicant's fingerprints suitable for conducting necessary background checks under this chapter and the applicant's social security number, for the same purpose;~~ *The full print out of a background check obtained from the Colorado Bureau of Investigation via the Internet Criminal History Check System (ICHC) dated within the past 30 days for each applicant;*

5. If the application is for a sexually oriented business license, the name, business location, legal description, business mailing address and telephone number of the proposed sexually oriented business;

6. Written proof *of* age, in the form of either:

a. A copy of a birth certificate and current photo;

b. A current driver's license with picture;

c. Other picture identification document issued by a governmental agency;

Section 3

To the extent only that they conflict with this ordinance, the Council repeals any conflicting ordinances or parts of ordinances. The provisions of this ordinance are severable, and invalidity of any part shall not affect the validity or effectiveness of the rest of this ordinance.
