

**VANCE BRAND MUNICIPAL AIRPORT
TERMINATION OF LEASE AGREEMENT FOR HANGAR PARCEL H-39**

This Termination of Lease Agreement ("Agreement") is made and entered into as of the _____ day of _____, 202_, between the City of Longmont, a municipal corporation, whose mailing address is 350 Kimbark Street, Longmont, Colorado 80501, hereinafter called the "City," and William F. Hannahan, whose mailing address is 3125 Sundown Drive, Berthoud, Colorado 80513, hereinafter called the "Lessee."

THE PARTIES RECITALS ARE AS FOLLOWS:

The Lessee is the former owner of a hangar (H-39) located at the Vance Brand Municipal Airport, in the City of Longmont, County of Boulder, State of Colorado, pursuant to an existing lease dated April 24, 2013, between the City and William F. Hannahan (known as the "Existing Lease"); and

Trusty Tassie Devil LLC is the requested assignee of the Existing Lease; and

Trusty Tassie Devil LLC is the new owner of Hangar H-39 and has or will enter into a new lease for H-39 with the City (the "New Lease"); and

The parties hereto desire to terminate the Existing Lease and replace it with the New Lease.

IN CONSIDERATION of the recitals, mutual promises, terms and conditions herein, and for other good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, the parties covenant and agree as follows:

1. The Existing Lease shall terminate as of the date that the New Lease becomes effective.
2. The New Lease must be approved by an ordinance of the Longmont City Council. If the Longmont City Council does not approve the New Lease, or if the New Lease is not executed for any other reason, then this Agreement shall be null and void.
3. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same Agreement. Facsimile signatures shall be acceptable and binding upon the parties.
