The August 11, 2020, Regular Session of the Longmont City Council was called to order at 7:00 p.m. by Mayor Brian Bagley via remote meeting connection.

### **6. CITY MANAGER'S REPORT**

#### **A. Update on COVID-19**

Susan Motika of Boulder County Public Health (BCPH) provided an update on the state mask order that expires August 15<sup>th</sup>, shared details about a sentinel survey they did which showed 95% of those observed complied with the mask order, described collaborative activities happening to prepare guidance on outbreak procedures for schools, and provide an update on the COVID cases in the County, concluding that hospitalizations were trending upward but officials are watching it closely. Susan also shared that BCPH is in the process of hiring ten case investigators so they can satisfy the metrics necessary to support moving to Protect our Neighbors.

Council Members inquired about outbreak procedures and projections for what is expected once schools are back in session in-person.

Susan Motika responded that the interim guidance is being drafted in response to the procedures question and replied that there are concerns about the confluence of factors related to schools being back in session on top of the flu season and assured that the department is monitoring carefully.

Roberto Luna, Water Quality Lab Supervisor, provided a brief overview of what is called BioBot testing which is wastewater surveillance for COVID, noting that the testing started in May and 17 Front Range facilities are participating in the effort that is being led by the Colorado Department of Public Health. Robert shared that

the project involves sampling wastewater twice per week for one year, the analysis of the samples is done by Colorado State University, and that participation in the project will result in consistent data and messaging to the public. He concluded by advising that staff would bring back an agreement for the project in the coming weeks.

Lastly, Harold Domingez, City Manager, updated Council that the tokens for restaurants program was underway and getting positive feedback from the community. The Chamber of Commerce manages the program and restaurants are starting to report that they are seeing tokens used. He said that he has been contacted by others in the community wanting to purchase tokens.

## **8. FIRST CALL - PUBLIC INVITED TO BE HEARD**

Pat Davis, 1709 Harvard Street, spoke regarding Special Districts and asked that Council vote yes to re-instate the previous ordinance and thus rescind the current ordinance that allowed for residential metro districts. She indicated she was unclear about some amendments to the ordinance and when they were voted on but urged Council to wrap this discussion up.

Michael Belmont, 841 Tenacity Drive, encouraged Council to renew the contract for air quality monitoring with Dr. Detlev Helmig when it comes for approval on the August 25, 2020 agenda.

Abe Melendez, 1543 South Coffman Street, spoke in opposition to a traffic light at Pike and South Coffman and stated residents are seeing lots of traffic coming through and he noted his concerns for the children.

Megan Williams, 1213 Spruce Avenue, asked for increased access to the Library and said that with school starting, families need access to the Library. She opined that the current service levels do not allow for two working parents to help their students get resources.

Linda Schlocke, 2307 Sherri Mar Street, asked Council to vote and show that Longmont will no longer have special residential districts because of situations like her friend's who purchased a home and later realized the increased feeds and taxes without a vote or say about those funds.

Laura Lee Hinton, 432 Judson Street, asked for Council's 'yes' vote on the special districts item and asked for a citywide requirement for masks because many residents are not following the rules. She also said she disagreed with the need to put librarians at risk by opening the Library because there are many other ways to get books.

Jim Gibson of Denver, with a group called Citizens for Metropolitan District Reform, spoke in opposition to allowing residential metro districts because they shift the risk of investment from

developers to homeowners along with taxes and debt with no ability for residents to vote on how the money is spent. He stated that houses with metro districts pay higher taxes.

Caroline Powers, 1534 South Coffman Street, also spoke regarding a new traffic signal at Pike Road and South Coffman Street and echoed comments of the previous caller in opposition to the light and stated that residents were not allowed a chance to comment on the light. She also stated she is against metro districts.

Laurie Stanley, 1015 Longs Peak Avenue, thanked Council for bringing back the Accessory Dwelling Unit (ADU) laws for discussion and shared concerns she had with a large ADU in her single-family neighborhood. She stated that a variance should be required prior to a permit being issued for an ADU and no longer requiring setbacks has caused issues.

Kathy Fedler, Housing and Community Investment Manager, introduced the item for the Spoke Apartments on 518 Coffman developed by Boulder County to develop affordable rental homes on-site that must have an alternative agreement because of Telluride decision. She shared that the project will provide 73 total rental homes and all 73 homes will be affordable. She noted that annual reporting would be required, the property would be deed restricted, transportation is convenient, the property is across from Boulder County's Hub building, that the Longmont Downtown Development Authority (LDDA), the City and the County all contributed land to the project, the building will have a structured parking garage that will be shared and a common interest community formed within the parking garage allocating some spaces to housing, some to commercial and a lease back option to the LDDA.

Council expressed their approval of and excitement for this project and discussed with Kathy ways to increase the number of units available at 50% of Area Median Income (AMI).

## **12. GENERAL BUSINESS**

### **A. Housing and Human Services Advisory Board Recommendations For Second Quarter 2020 Affordable Housing Funding**

Kathy Fedler, Housing and Community Investment Manager, reviewed the second quarter Affordable Housing funding application cycle, stated that the available funding total for 2020 was \$2,225,800, and reviewed allocations made to date totaling \$1,425,000. She also reviewed the Community Development Block Grant (CDBG) funding which was all allocated in early 2020 to the Inn Between for purchase of a property and the Longmont Housing Authority for refinance and rehabilitation of Aspen Meadows. She shared that the Inn Between found a property with 12 units and that the refinance of Aspen Meadows was proceeding and expected to close in late September 2020. With regard to HOME Funding, Kathy reminded Council that the entire amount for 2021 had been set aside for the Boulder County Housing Authority's Spoke Apartments.

For the second quarter funding cycle, two applications were received and one of those was withdrawn. Kathy said the other requested HOME CHDO (Community Housing Development Organization) funding for the Habitat for Humanity Mountain Brook new construction in the amount of \$120,000. Kathy explained CHDO funding and posed questions to Council: Should the City further subsidize a non-profit providing housing on behalf of a for-profit developer? Is a developer fulfilling their Inclusionary Housing requirement if the non-profit still needs additional city funding to provide the housing? Kathy noted that these questions were discussed by the Housing and Human Services Advisory Board and the Technical Review Group and both groups felt that since Habitat intended to have for sale houses hit 55% of AMI, that was a compelling reason they recommended this for funding at this time. Kathy asked that Council discuss these questions and noted that staff intends to bring back proposed Inclusionary Housing code changes around the end of September.

Council briefly discussed the questions.

Council Member Christensen shared condolences for the family of Konrad Steffan, a colleague from her days at the University of Colorado – Boulder.

Council Member Rodriguez expressed his respect for his fellow Council Members and the work each does with the best intentions for the entire City.

Council Member Martin spoke to the comments made about the traffic light at Pike and Coffman Streets and stated that a number of people asked for the light and all were invited to the same meeting as the neighbors of the various surrounding neighborhoods. She informed the public that the best time to get involved is when the City offers a chance to be engaged because if the City and Council hear from residents after the fact, it is often too late and decisions that implement changes have been made.

Council Member Peck stated for the record that Jim Angstadt, Senior Civil Engineer, that there is no intention to change South Coffman street from a local street to a collector street.
