2 A RESOLUTION OF THE LONGMONT CITY COUNCIL CALLING A SPECIAL  
3 MUNICIPAL ELECTION TO BE HELD TUESDAY, NOVEMBER 3, 2020, CONCERNING  
4 ISSUING BONDS PAYABLE FROM THE CITY'S WATER UTILITY ENTERPRISE  
5 REVENUES TO FINANCE WATER CAPITAL PROJECTS AND AN AMENDMENT TO  
6 THE CITY OF LONGMONT HOME RULE CHARTER TO ALLOW FOR LEASES OF CITY  
7 PROPERTY FOR UP TO 30 YEARS

9 WHEREAS Section 2.3 of the City of Longmont Home Rule Charter provides that a  
10 regular City election shall be held on the first Tuesday in November in each odd-numbered year;  
11 and

12 WHEREAS Section 2.9 of the City of Longmont Home Rule Charter provides that the  
13 Council may call a special election by adopting a resolution stating the purpose of the election at  
14 least thirty days before the special election; and

15 WHEREAS Section 2.04.085 of the Longmont Municipal code provides that for the  
16 purposes of participating in coordinated elections as defined in the Uniform Election Code of  
17 1992 and only for those purposes, the city will adopt and follow the requirements of that code as  
18 now existing or hereafter amended or modified; and

19 WHEREAS Section 2.04.090 of Longmont Municipal code provides that Special  
20 elections shall be held on any Tuesday, as set by City Council resolution and that no special  
21 election shall be held within the ninety days preceding a regular city election; and

22 WHEREAS the Longmont City Council has determined call a special election on the  
23 ballot question and the ballot issue stated in this resolution;

1           NOW THEREFORE, THE COUNCIL OF THE CITY OF LONGMONT, COLORADO,  
2 RESOLVES:

3   Section 1

4           The City of Longmont shall conduct a special election on NOVEMBER 3, 2020, as a  
5 coordinated election with Boulder and Weld Counties, at which election the qualified electors of  
6 the City of Longmont shall vote on a ballot title substantially as stated in the ordinance  
7 submitting the proposed Charter amendment and the resolution submitting the proposed ballot  
8 question.

9   Section 2

10          The Council repeals all resolutions or parts of resolutions in conflict with this resolution,  
11 but only to the extent of such inconsistency.
