2	A BILL FOR AN ORDINANCE MAKING ADDITIONAL APPROPRIATIONS FOR
3	EXPENSES AND LIABILITIES OF THE CITY OF LONGMONT FOR THE
4	FISCAL YEAR BEGINNING JANUARY 1, 2021

6	WHEREAS, under Article IX of the Longmont Charter, the City Council has, by Ordinance
7	O-2020-52, adopted the City of Longmont Budget for fiscal year 2021; and
8	WHEREAS, the City Council of the City of Longmont passed appropriation ordinance O-
9	2020-53, O-2021-05, O-2021-12, O-2021-15, O-2021-31, O-2021-39, O-2021-43, and O-2021-50
10	for the fiscal year 2021, providing for expenditures in the General Fund in the sum of \$96,389,061,
11	the Sanitation Enterprise Fund in the sum of \$9,707,366, the Golf Enterprise Fund in the sum of
12	\$3,487,299, the Callahan House Fund in the sum of \$129,346, the Lodgers Tax Fund in the sum
13	of \$200,000, the General Improvement District Fund in the sum of \$121,936, and the Fleet Fund
14	in the sum of \$11,525,106; and
15	WHEREAS, the following list shows estimated actual expenditures and encumbrances for
16	certain funds:
17	General Fund - \$96,561,940 (original appropriation of \$88,903,569, additional
18	appropriation of \$7,485,492, federal grant revenue of \$32,766, miscellaneous revenue of
19	\$113, and contribution of \$140,000 from the fund balance portion of the General Fund);
20	and
21	Sanitation Enterprise Fund - \$9,777,389 (original appropriation of \$8,639,333, additional
22	appropriation of \$1,068,033, and state grant revenue of \$70,023); and

1	Golf Enterprise Fund - \$3,509,299 (original appropriation of \$2,902,124, additional
2	appropriation of \$585,175, and charges for services revenue of \$22,000); and
3	Callahan House Fund - \$144,346 (original appropriation of \$128,376, additional
4	appropriation of \$970, and charges for services revenue of \$15,000); and
5	Lodgers Tax Fund - \$300,000 (original appropriation of \$150,000, additional appropriation
6	of \$50,000, and lodgers tax revenue of \$100,000); and
7	General Improvement District Fund - \$127,936 (original appropriation of \$121,654,
8	additional appropriation of \$282, and contribution of \$6,000 from the fund balance portion
9	of the General Improvement District Fund); and
10	Fleet Fund - \$11,825,106 (original appropriation of \$9,872,020, additional appropriation
11	of \$1,653,086, and contribution of \$300,000 from the fund balance portion of the Fleet
12	Fund); and
13	WHEREAS, the Council finds it necessary to make additional appropriations for
14	unanticipated expenditures required of the City; and
15	WHEREAS, actual and anticipated revenues for the year for certain funds, including
16	drawing on fund balance, are exceeding revenues estimated in the 2021 Budget in amounts
17	adequate to fund additional appropriations within those funds; and
18	WHEREAS, the Council finds that every contract funded in this ordinance for a charitable,
19	industrial, educational, or benevolent purpose, or with any denominational or sectarian institution
20	or association, serves a public purpose.

NOW, THEREFORE, according to sections 9.4 and 9.12 of the Charter of the City of
Longmont,
