

1 RESOLUTION R-2021-

2 A RESOLUTION OF THE LONGMONT CITY COUNCIL APPROVING THE CITY OF
3 LONGMONT SERVICES CONTRACT FOR PUBLIC, EDUCATIONAL, AND
4 GOVERNMENTAL (PEG) ACCESS TELEVISION SERVICES

5
6 WHEREAS public access television services contracts with the Longmont Cable Trust or
7 any successor to that entity for providing public, educational, and governmental cable television
8 services to the residents of the city are to be approved by City Council and are not subject to the
9 procurement requirements of the Longmont Municipal Code (LMC) listed in section 4.12; and

10 WHEREAS the requirement for approval and exemption from the required competitive
11 purchasing process outlined in section 4.12 of the LMC does not preclude the City from opening
12 such services to full, open competition when direction is given by City Council to do so in the
13 public interest; and

14 WHEREAS under a motion of the City Council at the September 25, 2018 Regular
15 Meeting, the City of Longmont solicited proposals via a publicly advertised Request for Proposal
16 (RFP) for providing public communication services to include managing the Public, Educational,
17 and Government Access channels; and

18 WHEREAS the selection process was conducted in accordance with the LMC section
19 4.12.120, and followed the policies and procedures as outlined in the RFP; and

20 WHEREAS on December 15, 2020, the City Council approved the 2021 services contract
21 with Longmont Public Media; and

1 WHEREAS the City and the Longmont Public Media wish to enter into a new services
2 contract for providing public, educational, and governmental cable television services for the
3 year 2022.

4 NOW, THEREFORE, THE COUNCIL OF THE CITY OF LONGMONT, COLORADO,
5 RESOLVES:

6 Section 1

7 Pursuant to section 4.12.020(1) of the Longmont Municipal Code, the Council approves
8 and authorizes the Mayor to sign the Services Contract for Public, Education, and Governmental
9 (PEG) Access Television Services referenced in the title of this resolution in substantially the
10 form now before the Council.

11 Section 2

12 The Council repeals all resolutions or parts of resolutions in conflict with this resolution,
13 but only to the extent of such inconsistency.
