Subject: Year 2022 Utility Allowance Schedule

RECOMMENDATION

Adopt a Resolution establishing a revised Utility Allowance Schedule for use in the administration of Longmont Housing Authority (LHA) Housing Choice Voucher (Section 8) Rental Assistance Housing programs.

FISCAL IMPACTS OF RECOMMENDATION

There will be a very slight increase in Housing Assistance Payments (HAP) by the Longmont Housing Authority.

CURRENT SITUATION AND ITS EFFECTS

Annually, HUD requires Housing Authorities to review the utility costs in the area and update its Utility Allowance Schedule if the rates have an overall change of over 10%. The utilities for Longmont/Boulder County did not change by 10% in 2020 or 2021, so LHA did not adopt any changes to the Utility Allowance. When reviewing the utilities for 2022, it was discovered that Boulder County Housing Authority reviews and updates a Utility Allowance schedule for the vouchers it administers including in Longmont. In accordance with HUD allowances, LHA staff is proposing to adopt the Utility Allowance Schedule for Boulder County for 2022 instead of establishing a stand-alone utility allowance structure.

This Utility Allowance schedule may increase housing assistance payments for any re-certifications, moves and new admissions with an effective date beginning January 1, 2022. The increases in the utility allowance means that tenant rent payments may be correspondingly higher for tenants and LHA's housing assistance payment commitments may be higher to provide these allowances.
