A RESOLUTION FINDING A PARCEL OF LAND KNOWN AS THE RIVERTOWN ANNEXATION (GENERALLY LOCATED NORTH OF BOSTON AVENUE AND WEST OF SUNSET STREET AT 21 S. SUNSET STREET) ELIGIBLE FOR ANNEXATION

WHEREAS, the property proposed for annexation is described in the attached Exhibit "A;" and

WHEREAS, the City Council of Longmont, Colorado, has found the petition for annexation of the property proposed for annexation to be in substantial compliance with the requirements of section 31-12-107(1), C.R.S.; and

WHEREAS, the City Clerk has provided notice of Public Hearing on the proposed annexation by publication once a week for four successive weeks and by registered mail to the Clerk of the Board of County Commissioners, County Attorney, School District, and to any special district having territory in the area of the proposed annexation; and

WHEREAS, the City Council has completed a Public Hearing to determine if the proposed annexation complies with sections 31-12-104 and 105, C.R.S., to establish eligibility for annexation.

NOW THEREFORE, THE COUNCIL OF THE CITY OF LONGMONT, COLORADO RESOLVES:

## Section 1

The Council finds and concludes, regarding the annexation of the property described in the attached Exhibit "A," as follows:
A. At least one-sixth of the perimeter of the area proposed to be annexed is contiguous with the existing boundaries of the City of Longmont, Colorado and, therefore, because of such contiguity, the proposed territory meets the minimum eligibility requirements of section 31-12-104, C.R.S;
B. No land held in identical ownership has been divided or included as part of the proposed territory for annexation without written consent of the owners;
C. No annexation proceedings have been commenced by another municipality;
D. The annexation will not result in the detachment of area from a school district;
E. The annexation will not result in the extension of a municipal boundary more than three miles;
F. An election is not required under section 31-12-107, C.R.S;
G. The annexation completes the annexation of all platted streets within the area to be annexed;
H. No additional terms or conditions are to be imposed under section 31-12-112, C.R.S; and
I. The proposed annexation meets the applicable parts of sections 31-12-104 and 105, C.R.S and is therefore eligible for annexation.
