

# MINUTES City Council Regular Session

#### 1. MEETING CALLED TO ORDER

The December 7, 2021, Regular Session of the Longmont City Council was called to order at 7:00 p.m. by Mayor Joan Peck via remote meeting connection.

#### 6. CITY MANAGER'S REPORT

#### **A.** Update on COVID-19

Harold Dominguez, City Manager, reviewed the most recent data and statistics related to the COVID-19 pandemic noting the County is still in high transmission and that epidemiologists were working to better understand the new Omicron variant.

Council Member Waters asked who provides testing and how are results reported, and Harold responded that various providers provide tests and they all are required to upload their data to the state as a condition of offering testing.

#### 7. SPECIAL REPORTS AND PRESENTATIONS

A. A Special Presentation By The Left Hand Watershed Center And The Public Works & Natural Resources Department On The Status And Current Efforts Concerning Saint Vrain Creek Watershed Forest Stewardship Efforts And Calwood Fire Recovery Efforts

Mayor Peck introduced Jessie Olson of the Left Hand Watershed Center (LHWC) who provided a presentation about the Center and the work it does, and described efforts of the organization in their four focus areas: community engagement; river restoration; forest restoration; and management of watersheds. She explained that LHWC works to protect and restore watersheds for people and the environment using a collaborative, science-based approach, and has expanded their scope of work to include forests, rivers, farms and communities, and, has geographically expanded to include the entire St. Vrain Basin. Jessie shared special thanks to various City of Longmont staff for their partnership in this arena.

With the severe wildfire season this past year, the St. Vrain Forest Health Partnership was formed and this group, Jessie explained, is working to increase the pace and scale of forest restoration in the St. Vrain Watershed with the help of funding from various sources, including a request to the City to contribute \$134,004 to the Fire Recovery Funding that is included as an item on the Consent Agenda.

Council thanked Jessie for the informative presentation.

Mayor Peck further asked why the City is not releasing water from Union Reservoir and WasteWater Treatment facility and Ken responded that the City would continue to do that but this would allow the City to use this filing instead of the others which are used when the call is senior to 2021.
