The Lessee is the former owner of a hangar located at the Vance Brand Municipal Airport, in the City of Longmont, County of Boulder, State of Colorado, pursuant to an existing lease dated January 10, 2018 between the City and Chad Welch (known as the "Existing Lease"); and

J & J Hangar, LLC is the assignee of the Existing Lease; and

J & J Hangar, LLC is the new owner of Hangar Parcel H-33A and has or will enter into a new lease for H-33A with the City (the "New Lease"); and

The parties hereto desire to terminate the Existing Lease and replace it with the New Lease.

IN CONSIDERATION of the recitals, mutual promises, terms and conditions herein, and for other good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, the parties covenant and agree as follows:

- 1. The Existing Lease shall terminate as of the date that the New Lease becomes effective.
- 2. The New Lease must be approved by an ordinance of the Longmont City Council. If the Longmont City Council does not approve the New Lease, or if the New Lease is not executed for any other reason, then this Agreement shall be null and void.
- 3. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same Agreement. Facsimile signatures shall be acceptable and binding upon the parties.
