PLACES




Housing for All – Affordable and attainable/middle-tier housing Transportation – Multi-modal options with safety and Vision Zero at its core

Early Childhood Education – Ensuring children under five have the necessary resources




Progress is a Process

Housing - Milestones & Outcomes

Mission: Housing for all. Develop or improve programs, plans, and incentives that encourage the creation of affordable and attainable housing.

Desired Outcome: Notable increase in new affordable and attainable units utilizing incentive programs. Children grow up in stable housing. There is no need for 'safe lots'. Young people that grew up in Longmont can stay in Longmont. First time buyers are able to own a home in Longmont. Residents can live and work in Longmont. There is a robust talent pool from which to hire locally. Residents at any stage of life have flexible options. There is a sentiment among residents that 'yes, we are welcoming to all'.



*Roadmap to be further developed to be more reflective of numerous efforts beyond electrification.


Transportation Milestones & Outcomes

Mission: Provide more and various options for safe, comfortable, and efficient direct trips in town.




