3	OF A PORTION OF THE UNENCUMBERED APPROPRIATION BALANCE OF THE

7	WHEREAS, the City of Longmont maintains the General Employees Retirement Plan, a		
8	defined benefit retirement plan for non-uniformed general employees; and		
9	WHEREAS, the City of Longmont maintains the Police Pension Plan, a defined benefit		
10	retirement plan for police officers hired prior to April 8, 1978; and		
11	WHEREAS, the General Employees Retirement Plan receives its annual actuarial report		
12	in August of each year and that report identifies the actuarially required contributions for the		
13	current fiscal year; and		
14	WHEREAS, because of the timing of the actuarial report the City could not budget		
15	sufficient contributions to the General Employees Retirement Plan to meet the actuarial		
16	requirement in 2023; and		
17	WHEREAS, the Employee Benefit Fund has a fund balance of over \$10.3 million in 2023		
18	and has grown from growth in compensation and city contributions to the Employee Benefit Fund		
19	as a percentage of compensation; and		
20	WHEREAS, the Employee Benefit Fund has been used in the past to help offset an		
21	unfunded liability in the General Employees Retirement Plan; and		
22	WHEREAS, in September of 2023, City staff recommended to the City Council that a		
23	transfer of \$700,000 be made from the Employee Benefit Fund to the Employee Pension Fund		

1	during 2023 and that a transfer of \$20,000 be made from the Employee Benefit Fund to the Police	
2	Pension Fund during 2023 to make up the 2023 underfunded actuarial contribution requirement.	
3	NOW THEREFORE, THE COUNCIL OF THE CITY OF LONGMONT, COLORADO	
4	RESOLVES:	
5	Section 1	
6	Pursuant to section 9.11 of the Longmont Charter, the City Council hereby authorizes and	
7	directs the transfer of \$700,000 from the unencumbered appropriation balance of the Employee	
8	Benefit Fund to the Employee Retirement Fund and \$20,000 from the unencumbered appropriation	
9	balance of the Employee Benefit Fund to the Police Pension Fund:	
10	Section 2	
11	Transfers shall be recorded by November 30, 2023.	
12	Section 3	
13	The Council repeals all resolutions or parts of resolutions in conflict with this resolution	
14	but only to the extent of such inconsistency.
