8	WHEREAS the City of Longmont Colorado (the "City"), the Longmont Urban Renewal			
9	Authority (the "LURA"), the Twin Peaks Metropolitan District (the "District") and NMMS Twin			
10	Peaks, LLC (the "Developer") (collectively, the "Parties") are parties to a Redevelopment a			
11	Reimbursement Agreement, dated as of January 8, 2013 (the "Agreement") as part of the			
12	redevelopment of the Twin Peaks Mall into the Village at the Peaks; and			
13	WHEREAS the Agreement in part authorized the District to reimburse the Developer for			
14	up to \$7 million of costs incurred that were not originally reimbursed by the Certificates of			
15	Participation issued by the City; and			
16	WHEREAS the District desires to issue bonds to reimburse the Developer for such costs,			
17	and requests this First Amendment to the Agreement (the "First Amendment") to clarify LURA's			
18	continuing obligation to remit to the District the full 25 mills of unpledged operations are			
19	maintenance levy; and			
20	WHEREAS the Parties agree that the First Amendment is consistent with the intent and			
21	purposes of the Agreement.			
22	NOW THEREFORE, THE COUNCIL OF THE CITY OF LONGMONT, COLORADO,			
23	RESOLVES:			

1	Section 1					
2	The City Council authorizes the Mayor to sign the First Amendment in the form					
3	substantially as that now before Council for the purpose of clarification of the provisions of the					
4	Agreement.

7	but only to the extent of such inconsistency.
